A question was asked as to whether the Rushmere planning application would go to planning committee. Cllr Ceresa said that it is likely that it will be discussed at the next referral meeting.

Cllr Ceresa gave an update on issues relating to Windy Acres. The meeting between the Chair of the Planning Committee, ES Cllrs Ceresa and Rivett and the Clerk to Mutford PC with Planning and Enforcement Officers will be held on the 19th November.

ES Cllr Rivett reported that Sizewell C phase 4 is progressing and a planning application will be made to the Secretary of State in the Spring of 2020. Scottish Power are seeking to expand the offshore wind farms.

The East Suffolk Business Festival is being held from the 4th to the 18th November. The Chairman asked Cllr Rivett and Cllr Ceresa if they could arrange for copies of the information from the meeting to be sent to the Council.
