88/23/1 East Suffolk Council

East Suffolk Council have launched a draft of their new stragetic plan which they welcome comments on.

Polling Stations in East Suffolk are currently being reviewed.

88/23/2 Suffolk County Council

The Clerk read out the following sections from SCC Cllr Cloke's report for the month of September 2023:

Suffolk Fire and Rescue Service announced in June it would be withdrawing from the shared control room arrangement in place since 2011 with Cambridgeshire and Peterborough Fire and Rescue Service, based in Huntingdon. The report recommending

approval to Suffolk County Council's Cabinet, which sat on Tuesday September 12, says fire control would now be brought back into the county by the end of 2024.

A Suffolk care worker and her boss who saved a 101-year-old woman from an international scam that saw her fleeced of nearly £50,000 are being formerly recognised. Inflation, school transport for children with SEND, and looking after children in care are the main factors for SCC forecasting to spend £22.3m over its £688.1m budget for this year. Suffolk County Council projects a 4% OVERSPEND (£29.3m), to be partially offset by an additional Section 31 grant from Government, and additional income from the pooling of business rates with the district and borough councils in Suffolk, totalling £7m.

The march of pylons - In a joint letter to National Grid, the leaders of the three councils address the extensive impact on landscapes and local communities that the scheme would bring. They also highlight than an offshore solution has not been sufficiently investigated, and the opportunities that this could bring to co-ordinate with other large-scale energy projects off the region's coast.

Suffolk County Council has been awarded nearly £11.7 million to develop active travel schemes, including measures such as cycle lanes, shared-use paths, and improved crossing points on the roads. It is hoped that the improvements would help more people to walk, wheel and cycle in their everyday lives and to enjoy safer streets, reduced congestion and better health and air quality,

Playground - R. Mills reported that some lengths of timber are required to re-edge the bark pit at a cost of £160 including VAT. The purchase was agreed. **Proposed by Clir Glendinning, seconded by Clir Read**

90/23 Councillor Vacancies/Co-option - Update

The Clerk reported that an expression of interest in one of the councillor vacancies had been received and a co-option form had been completed by the interested party. It was agreed that Richard Simpson would be co-opted onto the Parish Council. **Proposed by Clir Warnes**, seconded by Clir Glendinning.

The new councillor signed the Declaration of Acceptance of Office in the presence of the Clerk.

91/23 Community Speed Watch Scheme

The Clerk informed council that 5 volunteers have now come forward to join the scheme. A minimum of 6 volunteers are required to begin the scheme.

A discussion was held on the idea of community self help and it was agreed that a community litter pick would be arranged. The date for the litter pick was set for Saturday 11th November. The Clerk will approach East Suffolk Services to obtain equipment for the litter pick.

92/23 Speedsign - Handover update

Cllr Warnes informed Council that he has not as yet discussed the handover of the Speed Indicator Device with the resident who has offered to take over responsibility of it.

93/23 Holly Lane Bridlepath - Update

Works to cut back the overgrown hedges on the bridlepath have not commenced. The Clerk will contact Suffolk Highways to determine when the works are due to be carried out.

Adjournment for questions from members of the public

Concerns were reported over a section of footpath in the village following a fall involving a member of the public The Clerk will report this on the Suffolk Highways reporting tool along with concerns of another section of footpath in the village. It was reported that there are large amounts of grass growing in the gutters on the roads and encroaching onto the footpaths. It was suggested that the Highways reporting tool can be used to highlight these issues.
